Minutes of the 3rd Review Meeting with NHM/ HMNEH States 09.01.2017 at Krishi Bhawan, New Delhi

- 1. A Review meeting was held in two sessions on 09.01.2017 at Krishi Bhawan, New Delhi with SMDs/senior officials/representatives of SHMs to assess progress of implementation of MIDH during 2016-17 and discuss issues related to overall development of Horticulture sector. The morning session was chaired by Shri Raghavendra Singh, Additional Secretary (Horticulture) DAC&FW and the afternoon session was held under the chairmanship of Dr. Shakil P. Ahammed, Joint Secretary & Mission Director (MIDH) (AC&FW).
- 2. List of participants for both the sessions is annexed (Annexure 1). Following states/UTs didn't attend:

Bihar, Assam (They informed with reasons), J&K, Delhi, Lakshadweep, Dadar & Nagar Haveli. Himachal Pradesh deputed one officer posted in Delhi.

Absence of states/UTs without information or seeking exemptions were noted with concern.

- 3. Dr. S K Pattanayak, Secretary (AC&FW) who was especially invited to address SHMs on Horticulture road map for future welcomed all the participants and wished them a very happy New Year, before inviting suggestions from all States to prepare a road map incorporating the steps to be taken with an ultimate aim to double the farmers' income with self reliance in achieving food & nutritional safety and sustainability.
- Secretary (AC&FW discussed about importance of horticulture and the major interventions which can be the game changer in horticulture sector. He urged states to make their suggestions more meaningful considering that there is a need to shift focus from production to Post Harvest Management to reduce losses due to perishability. He emphasised on following interventions under MIDH:
 - a. Protected cultivation-cost should further reduce, to be adopted by small farmers.
 - b. Quality planting material- traceability by way of labelling/tagging and needs to be matched with the expectations of farmers
 - c. There is a need to focus more on post harvest management and market linkages.
 - d. Major production centre of perishable horticultural produce to be linked to markets through railways.
 - e. Markets created under MIDH should be brought on the e-NAM platform.

- f. There is a need to highlight the success story of innovative and progressive farmers through various means such as departmental web portal, organising interviews at TV Channel (DD Kisan) etc.
- g. States should also focus on exports of surplus produce and production of processable varieties for food processing Industries. For this, close coordination with APEDA and MOFPI is required.
- 5. Shri Raghavendra Singh, Additional Secretary (Horticulture) DAC&FW wanted to know from \$\footnote{\text{states}}\$ the major hindrances in implementation of the mission and difficulties faced by them in receiving funds through treasury route. A common agreement of the House was that funds should directly be sent to SHM bypassing the treasury route as states are unable to utilize funds released by the Government of India due to huge delay in release of funds from the state treasury. To address the issue, AS (RS) directed the MIDH Division to write to Chief Secretaries of States as well as send letters from Hon'ble Minister Agriculture to State Ministers marking copies to Ministry of Finance highlighting the difficulties. He urged States to sensitize state officials on Skill Development and DBT compliance.
- Dr. Shakil P. Ahammed, Joint Secretary & Mission Director (MIDH) welcomed the participants and explained the broad objectives/agenda points of the review meeting. He requested to prepare and furnish five year road map, outlining roadmaps to achieve the targeted outcomes, for development of Horticulture in the States so that with modified guidelines, MIDH could be carried forward in an outcome oriented mode for the next five year. States were requested to furnish action taken report on directions of EC, if not already submitted, at the earliest. In this context, States were urged to prepare/ provide balance sheet of planting material so that while finalizing Action Plans, Area Expansion could be linked with availability of quality planting material. He requested all the states to make state level stakeholder consultation more engaging and meaningful so that the outcome of Zonal and National level stakeholder consultation take into account the state specific issues. He pointed out that the mismatch in figures available on the NHM/HMNEH portals and those which are sent by states with the release proposals. He requested that a Senior Level Officer of SHMs should at least once in a month verify the data entered on the portal and a counter signed copy should be furnished to this department authenticating the entered data. The Division would be constrained to cut allocation of States if regular updation of data in portals are not done by States.
- 7. JS(MIDH) further requested states to look for projectization by conceiving one project for the most prominent crop. The project should include all the activities in the horticultural value chain from availability of planting material, production practices, post production management, processing, storage, and transport. Comments/ views on NABCONS report was sought from states so as to decide investment focus on cold chain components. States were requested to address all pending issues within a

fortnight as the Division will be exercising the option of reallocation of funds amongst performing and non- performing states. He reiterated that since ISEC has been awarded to conduct Impact Evaluation Study of NHM and HMENH schemes, cooperation from SHM is warranted for a meaningful impact evaluation. All the states were requested to come forward with proposals for 2nd / 3rd instalment at the earliest furnishing necessary documents for the release.

- Shri. Pankaj Kumar, Director (Horticulture) pointed out that some discrepancies 8. in achievement data as reported by the state through online portal were noticed. He informed about the visit of Joint Inspection Teams (JIT) to states in the next few days to assess progress on ground. He highlighted importance of skill development and urged all SHM to seriously conduct/ complete at least one batch of gardeners training in collaboration with KVKs already affiliated by ASCI and also suggested skill training may also be conducted at other govt. Institutes provided the QP, content and curriculum are as per ASCI norms. He stressed upon the importance of digitization of beneficiary data and linkages of AADHAAR to bank accounts for DBT compliance. States were urged to digitize beneficiary data of 2016-17 on priority basis. States which still have not started using Hortnet were encouraged to use HORTNET without any further delay. He informed that trainings on Hortnet were conducted at multiple locations and Technical Director (NIC) was requested to conduct further training on HORTNET to enable state functionary to start using Hortnet (it was proposed to conduct a training session in Kolkata for SHM, WB where SHM Jharkhand would participate). He urged all the state to speed up expenditure so that the remaining targets would be achieved on time. States were also encouraged to come forward with proposals of inter-component changes intimating the achievable targets during the remaining time. He also discouraged any post-facto approval for exceeding physical targets of the approved AAP in the previous financial year. All the state were requested to furnish compliance on pending audit paras.
- 9. After the opening remarks, review of each state was taken up one by one. On the basis of performance data uploaded by the SHMs, state-wise Power Point presentation was displayed and discussed for each of the State. Following common points were observed, discussed and agreed upon:
- (a) For each State, the availability of fund (release of Central share plus unspent balance of last year) and the expenditure against the available funds was discussed. All the States assured to spend the remaining funds as soon as possible and submit request for release of next instalment.
 - Following states, which already got 2nd instalment should submit proposal for 3rd instalment by 20th of January:
 - AP, Goa, Haryana, Punjab, UP, TN, Karnataka, Gujrat, and Chattisgarh.
 - Following states shall submit request for release of 2nd instalment by 20th of January:

West Bengal, Bihar, Manipur, Tripura, Nagaland, Meghalaya

Following states have submitted requests for 2nd instalment but in case of some
of them requisite documents are not in order; they will reconcile and submit
the wanting documents:

Odisha, Kerala, MP, Telengana, Maharashtra, Rajasthan, Jharkhand, Sikkim, Uttarakhand, Mizoram.

It was noted with great concern that Arunachal Pradesh failed to submit request for even 1st instalment despite repeated reminders.

The table compiling the fund available and expenditure made against them, state-wise, is annexed (Annexure-2).

- (b) Physical achievement against 9 major interventions was discussed for each of the state. During the discussion it was noticed that almost all the states, except few, the performance in respect of planting material, PHM, and market infrastructure are not up to the mark.
 - Performance in respect of following states were noted below par:

Bihar, West Bengal (reported data need verification), Kerala, MP, UP, Maharashtra, and Chattisgarh.

- Performance in respect of following states were noted as OK:
 Haryana, Odisha, Telengana, Rajshthan, AP, Goa.
- Performance in respect of following states were noted as good:
 Punjab, TN, Karnataka, Jharkhand (but reported data need verification)

The table depicting percentage achievement reported by the state is annexed (Annexure-3).

- (c) In the NCCD-NABCONS Cold Chain study, state-wise requirement of cold storages and gaps in cold storage capacity was stated. It was noticed that the requirement of cold storages is less than the existing capacity. Comments on the negative gap of cold storages and huge gaps on other cold chain components- ripening chamber, integrated pack houses, reefer vehicles, etc.- were solicited from the States. A table compiling the existing cold storage capacity and requirement of cold storages, and gap in other cold chain components is annexed (Annexure-4).
- (d) Other remaining issues such as pending audit paras, skilling target for gardener, digitization of beneficiary data as part of DBT implementation, uploading the data in HAPIS Portal, uploading project based activities, and implementation of HORTNET were also discussed. The list of pending audit paras, skilling target for gardeners and number of beneficiaries data digitized is compiled and annexed (Annexure-5&6).

In the concluding session, Director(MIDH) thanked all the States for participating in the review meeting and hoped that states will stick to the promises made during the review meeting for utilizing fund expeditiously, step up their activities relating to overall progress of various interventions with special focus on PHM, market, and planting material activities, and take up new initiatives such as skilling and DBT in right Ernest.

He then summarized the major actionable points to be followed up by the SHMs in a time bound manner as under:

- States will speed up implementation of approved AAP in a time bound fashion and come up with proposals for release of 2nd/3rd instalment positively by 20th January 2017.
- At least one batch of skilling training will be completed by all SHM states through KVKs/SAUs by the end of March 2017
- Beneficiary data for 2016-17 shall be digitized by March 2017. Remaining states shall start using Hortnet. Issues regarding interoperability and data porting between state specific portal and hortnet (for UP, Rajshthan, MP, and Gujrat) shall be resolved immediately in consultation with Technical Director (NIC).
- States which have not furnished the 5 year roadmap were requested to submit the report immediately. The roadmap should be outcome oriented.
- SHMs who have not furnished ATN of directions of EC would submit the same at the earliest.
- Onus of checking uploaded achievement data lie on SMDs who will send countersigned and authenticated achievement report (which must be printed version of the online data) quarterly.
- Comments on NABCONs report, specifically negative gap on cold storages, shall be sent by states before next review meeting.
- Final review meeting of the entire financial year shall be conducted in the first week of April 2017.

The meeting ended with a vote of thanks.
